

This Addendum, to the **Cambridge University Press License Terms for Consortia 160516** is made between Cambridge University Press with offices at One Liberty Plaza, Floor 20 New York, NY 10006 (“Cambridge University Press”), and the Council of Prairie and Pacific University Libraries (COPPUL), whose principal office is located at Room 219 Koerner Library, University of British Columbia, 1958 Main Mall Vancouver, British Columbia V6T 1Z2 (“Licensee”), as of August 15, 2018, (the “Effective Date”).

COPPUL agrees to the **Cambridge University Press License Terms for Consortia 160516**, with the exception of a superseded definition and inclusion of additional clauses provided in this Addendum. Cambridge University Press have agreed to this Addendum for COPPUL and its Authorized Users. These changes apply to all COPPUL Products with Cambridge University Press. Cambridge University Press also agrees that the terms and conditions in these additional clauses in this Addendum shall be offered to individual Members of COPPUL with institution licenses.

The following numbers identify additional and/or superseded clauses in the **Cambridge University Press License Terms for Consortia 160516**:

1. DEFINITIONS: Authorized User: All current students, staff and faculty of a Consortium Member (whether full or part-time, permanent, temporary, contract or visiting appointments), and alumni of a Consortium Member, regardless of the physical location of such persons.

Authorized Users also include individual members of the public (walk-in users) while they are physically on the premises of a Consortium Member. For the avoidance of doubt, walk-in use is intended for individual users, not as a substitution for a license by another institution.

3.1.3 Interlibrary Loan

Supply to the library of an institution (whether by post, fax or secure transmission, using Ariel or its equivalent, whereby the electronic file is deleted immediately after printing) a single paper copy of a Product in accordance with the limitations agreed with the Licensor and provided that such copy may only be used for research, teaching and private study purposes and not for any Commercial Use.

3.1.4 Scholarly Sharing

Authorized Users may provide a single electronic copy of an individual document being part of the Products to a colleague who is not an Authorized User for Scholarly and Educational Use, but in no case for Commercial Use.

3.1.5 Academic Research and Teaching

Members and Authorized users may (a.) incorporate parts of the Products in printed or electronic form in assignments, portfolios, theses, dissertations, teaching, conference presentations, and lectures, with appropriate credit; (b.) make full use, with appropriate credit, of the Products in research and publications for personal, scholarly, educational, or professional use; and (c.) store a single copy of an individual document being part of the Products, including within secure personal Bibliographic Reference Management Systems. For the avoidance of doubt, none of these activities may be undertaken for Commercial Use.

3.1.6 Accessibility

Consortium Members may alter or modify the Products as necessary to provide an equivalent level of access to Authorized Users with disabilities if the Products are not already provided in Accessible Formats.

3.1.7 Course Packs, Electronic Reserves, & Electronic Learning Environments

Consortium Members and Authorized Users, subject to clause 6 in the Cambridge University Press License Terms for Consortia 160516, may incorporate parts of the Products in printed and electronic Course Packs and Electronic Reserve collections for the use of Authorized Users in the course of instruction at a Consortium Member, and/or in Electronic Learning Environments hosted on a Secure Network, but not for Commercial Use. Each such item shall carry appropriate acknowledgement of the source. Course Packs in alternate formats may also be offered to Authorized Users that require Accessible Formats.
