



**FIRST AMENDMENT TO AIP  
CONTENT LICENSING AGREEMENT – BOOKS COLLECTION**

This Amendment to the AIP Content Licensing Agreement – Books Collection (“Amendment”) is effectively dated as of March 15, 2021 (the “Effective Date”) by and between **AIP PUBLISHING LLC** (“AIPP”) and **Council of Prairie & Pacific University Libraries (COPPUL)** (“Licensee”).

**RECITALS**

**WHEREAS**, AIPP and Licensee entered into that certain AIP Content Licensing Agreement – Books Collection wherein AIPP agreed to provide a license to certain online materials (the “Existing Agreement”).

**WHEREAS**, AIPP and Licensee desire to make certain amendments to the List of Licensed Content and Fees scheduled to be paid for 2021 in the Agreement, as set forth in this Amendment.

**AGREEMENT**

**NOW, THEREFORE**, in consideration of the foregoing, of the mutual covenants and agreements hereinafter set forth, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, AIPP and Licensee, intending to be legally bound, covenant and agree as follows:

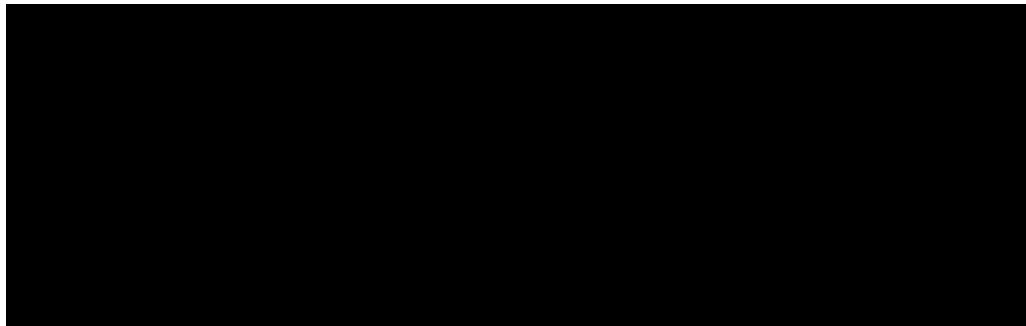
1. **Incorporation of Recitals.** The foregoing Recitals are hereby incorporated in and made a substantive, contractual part of this Amendment by this reference.
2. **Amendment to Existing Agreement Fee Schedule.** Effective as of the Effective Date, the Appendix A: Participating Institutions and/or Authorized Locations attached to the Existing Agreement shall be amended.
3. **No Other Changes.** All other terms, conditions and provisions of the Existing Agreement remain in full force and effect, except as modified by this Amendment.
4. **Binding Effect.** This Amendment shall be binding upon and inure to the benefit of AIPP and Licensee and their respective permitted successors and assigns.
5. **Counterparts; Electronic Signatures.** This Amendment may be executed in two (2) or more counterpart copies, all of which counterparts shall have the same force and effect as if the parties hereto had executed a single copy of this Amendment. Facsimile or PDF signatures shall be construed as originals.



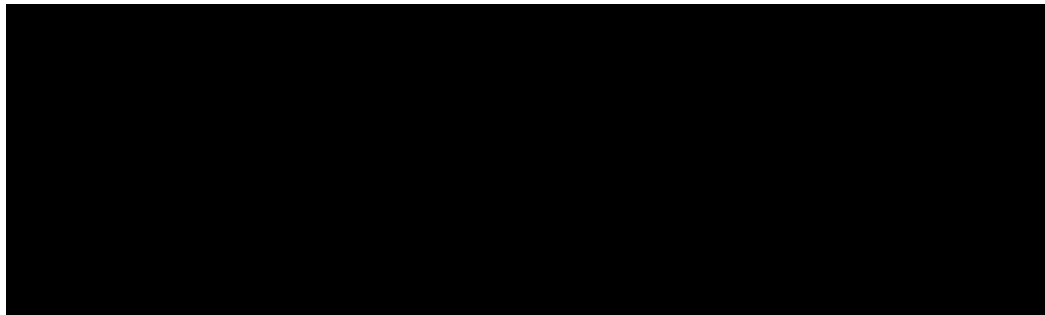
